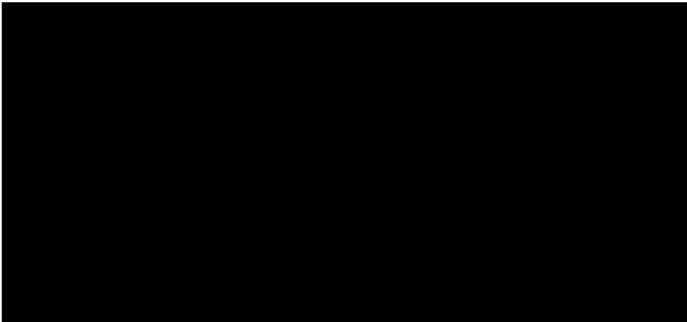

Thank you for your request dated 7 June 2022 pursuant to the Official Information Act (OIA) 1982, transferred by the Ministry of Health to Waikato DHB on 15 June 2022.

You requested the following information:

1. The total number of procedures outsourced by year (including the year to date) for the past five years.
2. For each year, provide a breakdown of the type of procedure.
3. For each year, provide the total spend on outsourced elective surgeries.
4. For each year, provide the amount that these surgeries would have cost the DHBs if they had not been outsourced.

The attached table provides a summary of the information requested for points 1, 2 and 3.

In relation to the information requested for point four it is difficult to provide an accurate cost of the procedures undertaken within the hospital as the complexity of patients varies considerably, i.e. many patients who have co-morbidities are not suitable to outsource to a private provider, therefore length of stay, medications, type of procedure undertaken, varies to the straight forward non-complex procedure. This information is therefore withheld under section 18(e) of the Official Information Act 1982 because the information does not exist.
